Answer **three** questions.

- 1 In a recent case, the jury forewoman explained to the judge that she and her fellow jurors had played games of Sudoku throughout the proceedings because it was difficult to maintain attention during the lengthy evidence.

To what extent does this highlight the inappropriateness of the role of the jury in complex proceedings? Can you offer any positive reasons for maintaining the present system of juries in the civil and criminal courts? [25]

- 2 Doris, who is 72 years old and has no previous convictions, pleads guilty at the Crown Court to importing a large quantity of heroin into the United Kingdom.

What sentencing options are open to the judge in this case? What principles will be considered in arriving at that decision? [25]

- 3 Barry, a 29 year old bus driver, wishes to become a magistrate.

Explain carefully the process of selection he will need to undergo, any difficulties you think he may encounter and the work he will have to undertake if selected. [25]

- 4 The judicial function of the House of Lords has now been abolished and replaced by that of the Supreme Court.

Discuss critically the function and achievements of the House of Lords and consider whether, in your opinion, the time had come for a change. [25]

- 5 Analyse critically the purpose, advantages and disadvantages of delegated legislation. [25]

- 6 In 1990, Lady Carbury purchases a painting from the art dealers Melmotte & Co., which they assure her is the work of the celebrated artist Ghiselli. In 2009 she takes the painting to the television programme 'The Fine Art Roadshow', where an expert advises her that her picture is a worthless fake. She now wishes to recover from Melmotte & Co. the £20 000 she paid for the painting.

Discuss briefly whether equity will assist her. To what extent has equity generally assisted those seeking remedies in the civil courts? [25]
